# Terms and Conditions of Entry for International Test Cricket Travel Research (Brisbane, Sydney & Adelaide) Promotion

# First up

- 1. These terms and the Schedule form the Conditions of Entry for this Promotion, and set out all of the information you need to know regarding this Promotion. #### Who can enter ... and who can't
